**RESOLUTION REAPPORTIONING  
COUNTY COMMISSIONER DISTRICTS**

**WHEREAS**, state law requires counties to reapportion their county commissioner districts after each decennial census, MCL 46.401, et. seq.,

**WHEREAS**, the official 2010 United States Census data has been published,

**WHEREAS**, it is within the statutory time limits for the Cheboygan County Reapportionment Committee to adopt a reapportionment plan,

**THEREFORE BE IT RESOLVED**, that the Cheboygan County Reapportionment Committee adopts the following reapportionment plan:

**District # 1     3,652**

Burt (680); Munro (571); Hebron (269); Mackinaw (539; Beaugrand (1,168) and Part of City of Cheboygan (425) described as lying southerly of Court Street and westerly of Western Avenue.

**District # 2     3,845**

City of Cheboygan (3,845), except that part in District 1 and District 3.

**District # 3     3,803**

Benton (3,206) and Part of City of Cheboygan (597) described as lying southerly and easterly of following described line: Commencing at the intersection of Garfield Avenue and south city limit line thence northerly along Garfield Avenue and South F Street to East State Street thence easterly along East State Street to Sutherland Street thence northwesterly along Sutherland Street to Duncan Avenue thence northerly along Duncan Avenue to the lake and point of ending.

**District # 4     3,573**

Inverness (2,261) and Mullett (1,312).

**District # 5     3,535**

Aloha (949); Grant (846); Koehler (1,283) and Waverly (457).

**District # 6     3,856**

Mentor (818) and Tuscarora (3,038).

**District # 7     3,888**

Ellis (596); Forest (1,045); Nunda (1,042); Walker (327) and Wilmot (878)

**BE IT FURTHER RESOLVED**, that this resolution and plan shall immediately be filed with the Cheboygan County Clerk.



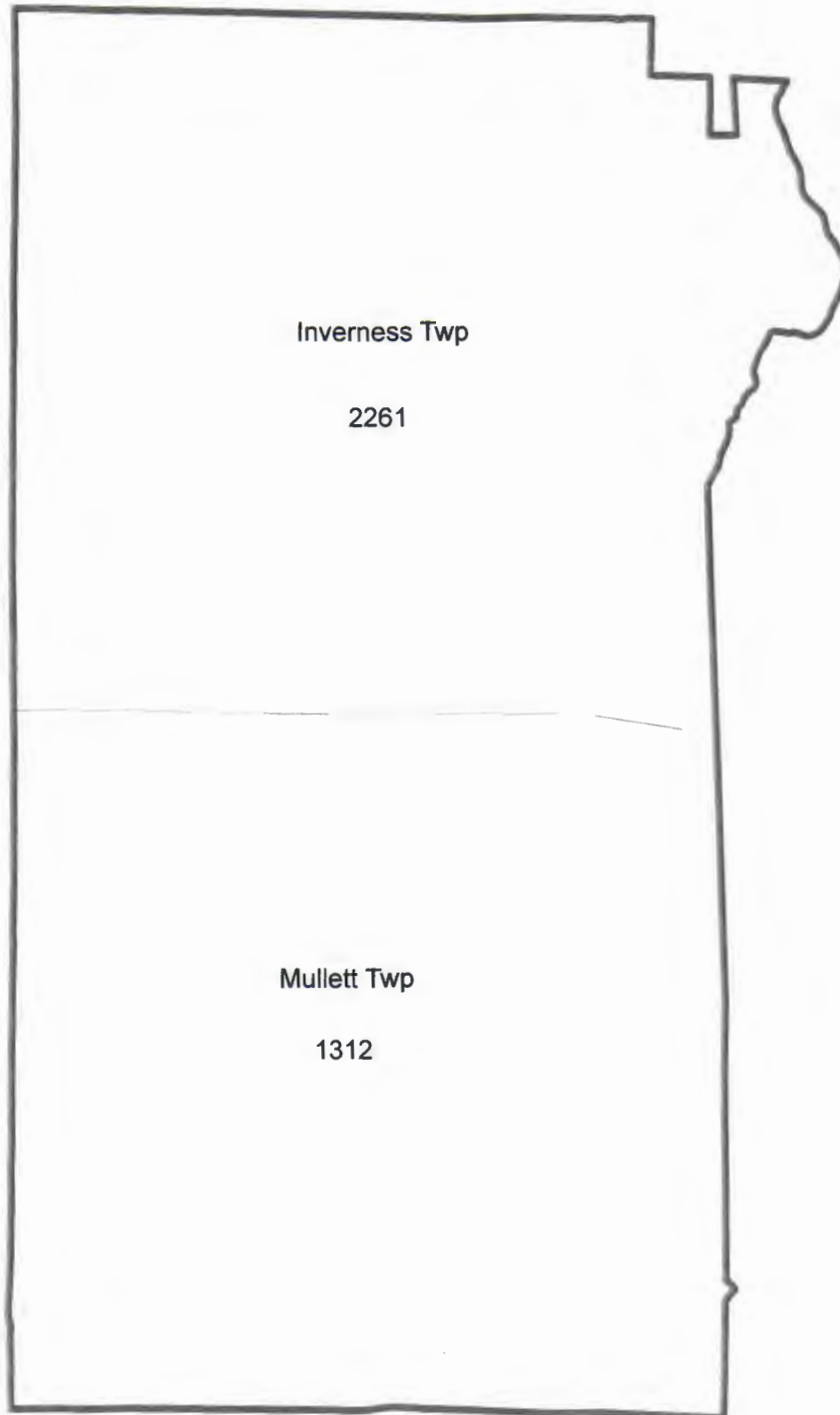

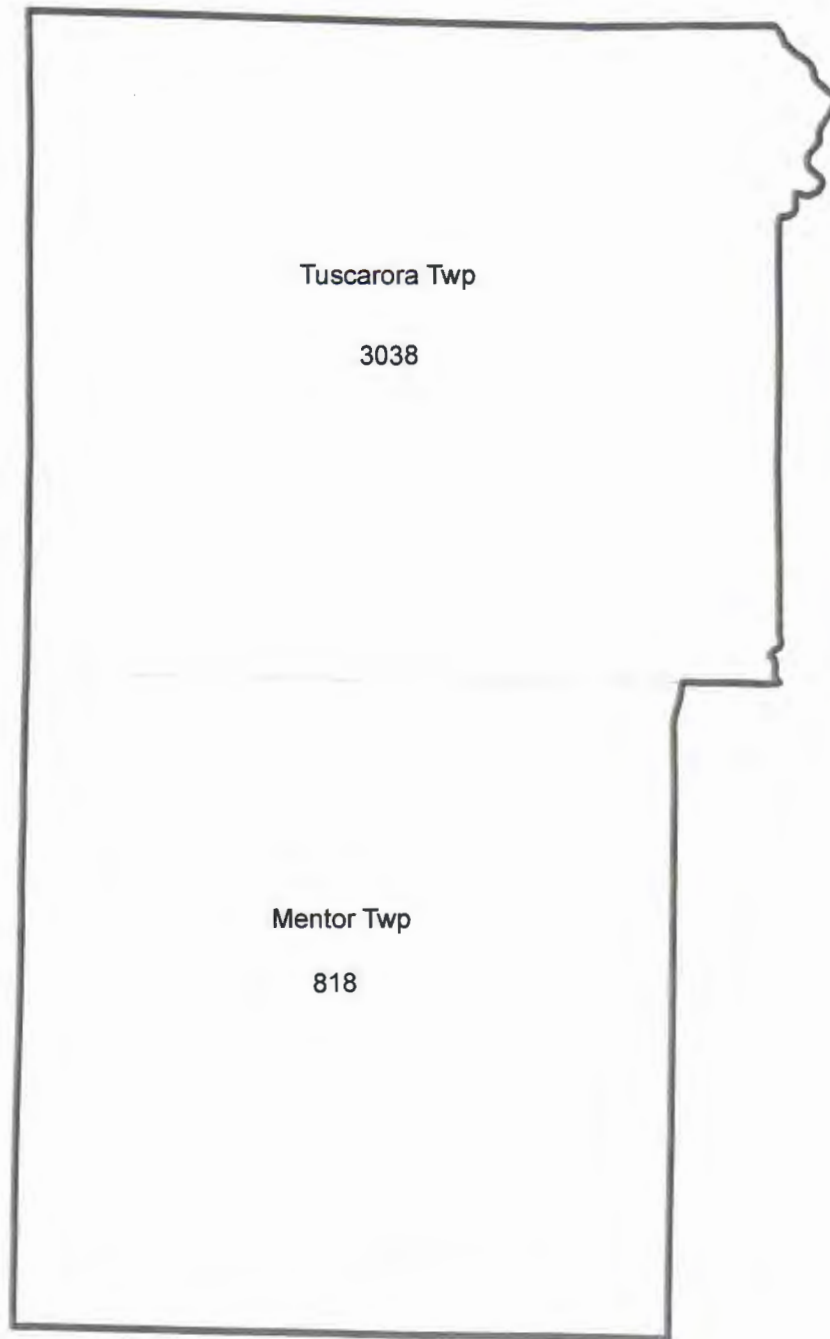
