## STATEMENT OF VOTES

The statement of votes polled in the one (1) voting precinct of the **Mackinaw City Public School**, at the Special Election held on Tuesday, **May 2, 2017**, and filed with the County Clerk and the Board of County Canvassers of Cheboygan County having duly examined and considered the statements, the whole number of votes given for and against the proposition reading as follows:

### SINKING FUND MILLAGE PROPOSAL

Shall the limitation on the amount of taxes which may be assessed against all property in Mackinaw City Public Schools, Cheboygan and Emmet Counties, Michigan, be increased by and the board of education be authorized to levy not to exceed .75 mill (\$.75 on each \$1,000 of taxable valuation) for a period of 10 years, 2017 to 2026, inclusive, to create a sinking fund for the purchase of real estate for sites for, and the construction or repair of, school buildings, for school security improvements, for the acquisition or upgrading of technology and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2017 is approximately \$113,025?
