Tuesday, **August 3, 2021** in Cheboygan County, Michigan and canvassed by the Board of Canvassers of Cheboygan County.

STATEMENT OF VOTES

The statement of votes polled in the voting precinct of Nunda Township, at the election held on Tuesday, **August 3, 2021**, and filed with the County Clerk and the Board of County Canvassers of Cheboygan County having duly examined and considered the statements, the whole number of votes given for and against the proposition reading as follows:

**Wolverine Community School District
Operating Millage Proposal**

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and restores millage lost as a result of the reduction required by the Michigan Constitution of 1963.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Wolverine Community School District, Cheboygan County, Michigan, be renewed by 18.00 mills (\$18.00 on each \$1,000 of taxable valuation) for a period of three years, 2023 to 2025, inclusive, and also be increased by 1.00 mill (\$1.00 on each \$1,000 of taxable valuation) for a period of four years, 2022 to 2025, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2023 is approximately \$1,014,908 (this is a renewal of millage that will expire with the 2022 levy and the addition of millage which will be levied only to the extent necessary to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963)?
