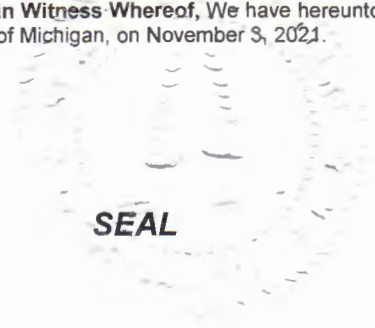



That having received sufficient number of votes **Mary Darling** and **Diane Mills** is elected to the **City Council of the City of Cheboygan**.


