### **2022 Preventative Maintenance Crack Sealing**

The Cheboygan County Road Commission will accept sealed bids for its Summer 2022 Over-Band Crack Fill & Crack Pre-treatment preventative maintenance program. Bidder must supply all necessary labor, equipment and materials for the Cheboygan County Commission over-band crack fill program, this also includes traffic control and mobilization. All traffic control operations must comply with the requirements set forth in the current Michigan Manual of Uniform traffic Control Devices. All materials and applications of material must meet ***MDOT Standard Specifications for Construction, 2022***. The successful Contractor shall submit material information to the Road Commission. The Road Commission will provide written approval of material to the Contractor. The Contractor must have written approval prior to any work being completed. Please specify bid amount for project completed before August 1, 2022 and/or bid price for project completed before September 31, 2022.

Bids shall be submitted on the enclosed CCRC Crack Sealing Bid Sheet in a sealed envelope clearly indentifying the bidder and marked "Crack Sealing".

Bids are due at **9:00 a.m. Tuesday June 14, 2022**, at which time, the bid will be publicly opened and read aloud. Bid results will not be available until they have been tabulated and presented with recommendations and approved by the Road Commission Board at their next regular meeting on June 16th, 2022.

Cheboygan County Road Commission reserves the right to accept or reject any and all bids, in whole or in part; to waive irregularities or informalities; and to award bids, in whole or in part, as deemed to be in the best interest of the Cheboygan County Road Commission.
